Re: Convention Delegate Election Protest Local 400 Joint Council

Dear Brother Casstevens:

This is an appeal under Article 8 Sections 15-17 of the constitution of the delegate election in the joint council of Local 400. The election was held on Sunday, May 7, 1989. This will supplement appeals that were previously filed by Ron Maxwell dated March 29, 1989, and Larry Reichle dated April 14, 1989, which I incorporate into this protest.

Local 400 is currently in Region 1B. Local 400 is an amalgamated unit. The joint council elected 2 delegates with voting strength of 12 votes. The delegate positions were won by the "New Unity Group." According to its literature, New Unity Group candidates supported Bob Lent for regional director, as well as the policies of Owen Bieber and the Bieber administration.

It has come to our attention that numerous violations occurred in the election of convention delegates. The specifications are as follows:

- 1. The joint council refused to allow nomination to any member of Local 400 who was not a member of the joint council.
- 2. The election committee placed the names on the ballot in alphabetical order, thus ensuring that the New Unity Group candidates appeared first on the ballot. The ordinary procedure is draw ballot position by lot.

- 3. We were not informed there would be any numbers or what our numbers were until the meeting occurred where the voting took place. The New Unity Group candidates on the other hand were informed in advance and were able to print literature with their names and ballot numbers on it.
- 4. International union staffers and representatives have been required to contribute money to the "Social Affairs Club" or the "Social Club" or the "Flower Fund" or some other fund, a conduit of funds for Administration Caucus candidates of which Bob Lent is one. The amount in this account sums to \$400,000, and is an unfair use of union resources in support of a candidate.
- 5. These contributions violate the constitution whether or not made under threat or coercion.
- 6. Administration Caucus candidates have established a union-wide centralized policy of abusing union resources to support Lent candidates in all of the large locals.


